The aforementioned cartridge was tested according to the specific material requirements of the LFGB (German Food and Feed Act). The tests were performed based on the Commission Regulation (EU) No. 10/2011, the German Consumer Goods Regulation, Regulation (EC) No 1935/2004 and BfR Recommendation IX on Food Contact Materials, each in their applicable version at the time of testing. Regarding the parameters tested, the filter system complies with the requirements of the LFGB and is thus considered as suitable for the intended use in the foodstuff industry, where it may come into contact with drinking water.
